GENERAL RULES

1. Competition is open to all kids Pre - Kinder thru 2nd grade, who are either enrolled in McMullen County ISD or reside in McMullen County. They must be enrolled in school for the current year and regularly attend classes. Each exhibitor must meet the guidelines set forth in the Texas Education Code. Enrollment in 4-H or FFA is NOT required. *All animals must meet the regulations governing admissions of livestock into shows set by the Texas Animal Health Commission.
2. **Deadline to enter the show will be January 20, 2025**
3. There will be one class per division of Swine, and Goats ONLY. No weigh-in is necessary.
4. No validation is required but the animal can be a sibling's, relative's or friend's validated animal.
5. **All exhibitors must be present and enter the show ring with their animal when their class/time is called. If not present the animal will be returned to its pen and will not show.** If an animal is wild or unruly, or poses a threat to the exhibitor, or others, during their class at the show, the judge or the superintendent of that division will be allowed to sift the animal.
6. Each exhibitor is encouraged to turn in a thank-you letter along with a stamped envelope to a Fair Board Member. This is to thank the donors of the prize (trophy and/or buckle) you received.
7. The Fair Board reserves the final and absolute right to interpret these rules and arbitrarily settle and determine all matters, questions, and differences in regard thereto, and the right to amend or add to these rules as its judgment may determine. An exhibitor who violates any of these rules will forfeit all privileges and premiums.
8. **PROTEST:** All protests must be in writing and accompanied by a deposit of \$25.00 (cash) which will be forfeited if protest is not sustained. Such protest must state plainly the cause of the complaint or appeal and must be delivered to the Tilden Livestock Scholarship Association Board president at least 1 hour prior to judging. Judging procedures will not be interrupted for protest investigation; and, depending on the basis of the protest, a decision may be withheld until a thorough investigation process is completed. All costs incurred in the investigation process shall be the sole responsibility of the party bringing the complaint.

DRESS CODE RULES

These rules apply to all exhibitors in the show ring:

1. Long sleeved button up shirts are required. Shirttails must be tucked in.
2. No T-shirts or polo shirts will be allowed.
3. No short pants, tennis shoes, canvas shoes or hats of any type.
4. Footwear must be western style and leather in appearance.
5. No chewing gum.
